Practising certificate fees are payable to the Legal Practitioners Fidelity Fund and are not subject to GST. Membership is free to practising certificate holders. Tax invoices will be issued upon compliance (including payment) with the requirements of the *Legal Profession Act 2006*. Practising certificate and late fees are based on the Revenue Unit and increase each year on 1 July.
